The afternoon will be highlighted by an educational panel, breakout sessions, and a networking reception.


On Friday, attendees reconvene at 7:30 for Breakfast, followed by The Innovative Initiative presentation, and a

Getting to Know You— Illinois Board of Higher Education

The Illinois Board of Higher Education (IBHE) is an excellent source of information about higher education in the State of Illinois. Their website has continually updated education news, links to consumer information about higher ed, campus safety issues, grants, legislation, and a wealth of additional areas . In addition, IBHE distributes a link to their newsletter "The Friday Memo" by email every Friday, to which you can subscribe.

IBHE was created in 1961 by the Illinois General Assembly and then-Governor Otto Kerner. The goal was to "create an agency with the expertise, credibility, and statewide perspective to map an efficient and orderly course for the dramatic growth of higher education then underway."

IBHE consists of sixteen members—ten appointed by the Governor, one representative each of public universities, and private colleges and universities, the chairs of the Illinois Student Assistance Commission and the Illinois Community College Board, and two student members chosen by the Student Advisory Committee, one of whom must be a nontraditional student.

IBHE's mission is to ensure access to "an affordable, high quality postsecondary education to meet the needs of all Illinois residents."

To achieve these goals, the Board has the authority to approve or reject proposals by public university governing boards and the Ill. Community College Board for new units of instruction, research, or public service. They also grant authority to operate and grant degrees for independent and out-of-state institutions.

State and federal educational grant funds are also administered by IBHE. For example, the *Higher Education Cooperation Act* provides grants for educational initiatives

These professionals shared low-cost, effective marketing and promotion strategies that have been successful at their respective institutions.

The networking lunch gave participants an informal opportunity to discuss activities and programs. Evaluations were very positive and participants specifically cited the benefit of practical discussions with real "hands on" focus. Everyone agreed that the spring regional conference is always one of the best professional bargains around!

Student Veterans and the SVA

Over 520,000 veterans are currently using their education benefits. When the new GI Bill goes into effect in August 2009, more than half a million additional veterans are expected to head for campus.

Many have founded local student organizations on college campuses to provide peer-to-peer networks. **Student Veterans of America (SVA)** is a coalition of student veteran organizations on college campuses across the United States, and is one of the most rapidly growing grassroots veterans organizations in the United States today.

Since its founding in January 2008, SVA has expanded from 12 initial member groups to student veteran groups on over 80 campuses.

SVA has three main goals:

• Develop student veteran groups on college cam-

puses and coordinate by region between existing groups

from Illinois Student Asst. Commission

- Connect student groups and university administrators with resources while aiding veterans transitioning into higher education
- Advocate on behalf of student veterans at the state and national level

Thousands of veterans exit military service every month, only to find an overwhelming combination of emotional, financial, and cultural obstacles standing between them and a college education. SVA is dedicated to ensuring these veterans do not slip through the cracks on their journey through higher education toward a better quality of life.

WHAT'S HAPPENING-AROUND THE STATE

Oakton Community College

Professor Pamela Hegg has been selected as a recipient of the prestigious Instructional Technology Council **Outstanding Distance Learning Faculty award** for 2009, along with co-honoree Sharon Rifkin from Broward College in Florida. Professor Hegg's energy, enthusiasm and commitment to her students and to technological innovation helped secure the award. Recipients will receive a complimentary registration to attend e-Learning 2009 in Portland, Oregon this coming February.

Saint Xavier University

The Leadership Academy of the Southwest Suburbs will hold professional training seminars beginning February 2009 at St. Xavier University 's Orland Park campus. Each session will run from 8:30 a.m. to noon. LASS trains and motivates local business professionals who wish to advance their leadership capabilities and strengthen their businesses.

Eastern Illinois University

Approximately 18 months ago, Eastern Illinois University's School of Continuing Education began development of a Lifelong Learning Institute. At the recommendation of an ad hoc committee made up of community members, annuitants and University administration, the Academy of Lifelong Learning was officially formed in April of 2008, seating an advisory board of 13 members.

The purpose of this effort is to provide all 50+ community members an outlet for their creative and educational needs. Much of the growth in higher education institutions in the years to come will be through serving the entire community not just the traditional student. The School of Continuing Education best understands the nontraditional student through serving their specific needs for decades; we see it as our duty and privilege to

continue to provide a wide variety of innovative programming to meet the changing needs of the nontraditional student.

Elmhurst College

The School for Advanced Learning in conjunction with the Department of Geosciences is starting a mid-year online Geographic Information Systems Certificate Program (GISCP) in response to increased demand for GIS technical skills. This nondegree, four course certificate, has been offered annually by the college since fall of 2006. The GISCP is an attractive professional development option for people employed by municipalities, environmental planning organizations, and the US military. 
University of Illinois at Urbana Champaign

January 8 through 10, 2009 Conferences & Institutes and UIUC will host the 34th Annual Illinois High School Theatre Festival (IHSTF). Over 150 high schools from across Illinois will participate in the Festival in January. The IHSTF is the largest and oldest non-competitive high school theatre festival in the world. Each year, over 4,000 students, teachers, university representatives, exhibitors, and volunteers come together for three days to put on over 25 different high school productions and over 190 workshops. Other highlights include college/ university auditions for high school seniors, professional development for teachers, and the annual All-State Production, featuring student cast, crew, and orchestra members from across the state. Hosting of the IHSTF is shared with Illinois State University and 2010's Festival will be on the ISU campus.

Bradley University

Continuing Education at Bradley University has hired a **new Program Director**, Michelle L. Riggio. Ms. Riggio will work with the Osher Lifelong Learning Institute in addition to other programs. She is a former special education teacher and public information officer.

American Council on Education - and the Higher Education Act

The American Council on Education has prepared a 10-page summary, highlighting the major features of the new **Higher Education Act** signed into law on August 14, 2008, and effective immediately. The following is an except from their report:

"On July 31, Congress completed reauthorization of the Higher Education Act (HEA) by passing the Higher Education Opportunity Act—five years late and after an unprecedented 14 extensions of the statutory deadline. The president signed the bill into law on August 14, 2008. Except for rules regarding relationships between higher education institutions and student lenders, the act does not address federal student loan programs, which were reauthorized and modified by the 2007 College Cost Reduction and Access Act.

Although the act includes burdensome new reporting, disclosure, and other requirements, it reflects noteworthy progress in that Congress was persuaded to reject yet more onerous and problematic proposals. As the bill is hundreds of pages long, this summary highlights selected key new provisions only."

The following topics are addressed in the Higher Education Act:

College Costs—various provisions aimed

at the rising cost of education

- Accreditation—one of the most controversial of the Act's provisions
- Student Financial Aid—including Pell Grant, Veteran benefits- including a right to readmission under certain circumstances, and provisions for students with intellectual disabilities, to increase access to financial aid
- Key Disclosure & Compliance Provisions related to campus climate, including campus safety, peer-to-peer file sharing, and textbook cost containment
- Student Loan "Sunshine" Provision—the federal government will for the first time regulate private educational lending
- Title II—Teacher Professional Development includes additional grants to improve teacher training and pro. development
- Title VI–International Education—includes several key provisions
- Studies—authorizes various studies
- Effective Date and Next Steps—includes nearly 70 new programs, although many are not expected to receive funding.



gram complies with the 10th Judicial Circuit Court's administrative rules and will qualify each participant to act as an attorney representing children per Supreme Court Rule 908.

Participants will hear from the leading experts in each of the areas specifically mentioned in Rule 906, have the opportunity to participate in panel discussions to develop networking and problem-solving skills, and learn about the applicable law from judges who provide the viewpoint from the bench. Attorneys must have appropriate training if they wish to act as an attorney for the child, a child representative, or GAL in all cases covered by Rule 900, including juvenile. This program will meet attorney requirements under the Tenth Judicial local rules, and possibly other circuits that adopt it. CLE hours applied for. Cost is \$400. Spotlight—Preston Morgan - Retiring! By Hilary Ward Schnadt

In this issue, the spotlight is turned on Preston Morgan, the Illinois Community College Board's ex officio member of the Executive Committee—and not a moment too soon.

Preston retired from the ICCB on December

Preston Morgan 31, and took the time to respond to ICCHE's interview request just before tackling the first of a series of assignments planned for his retirement. "I will keep working as long as I am needed," he promised. "However, I do want to find some time to kick back and relax. I have not had a vacation in over 11 years." IC-CHE has long benefited from that work ethic, and we are glad to have this opportunity to pay one final tribute.

Preston's career at the ICCB spanned 23 years and a variety of roles. The common denominator was a role central to workforce development. As he summarizes, "I have run programs through the Job Training Partnership Act (JTPA) and the Workforce Investment Act (WIA). I have reviewed new units of instruction and course requests, reviewed adult education area and institutional plans, developed and administered grant programs, coordinated the delivery of statewide training and education for businesses, staffed articulation committees, planned statewide conferences and meetings, and even assisted in the formation of a statewide community college system foundation." He retired from the position of Senior Director for Workforce Development.

His extra-curricular service to the State's workforce development efforts helped position him for his ICCHE role. When then ICCHE President Mary Bates approached President and Chief Executive Officer Geoffrey Obrzut to request the Illinois Community College Board provide a staff person to serve on the ICCHE Executive Committee in an exofficio capacity, Preston was already serving on two boards for community college associations and seemed like the natural choice. "Of course it didn't hurt that I had already had experience with ICCHE by being a member for several years and attended many of the meetings and conferences. I was thrilled to be asked and proudly accepted the assignment. I have served on the ICCHE Executive Committee for about three years" he reports.

Preston describes the cooperation and collaboration among Illinois higher education institutions as one of the great strengths of the State's higher education systems. ICCHE's role as a facilitator of collaboration between community colleges and public and private four-year institutions is also crucial. "As the workplace has become more complex and lifelong learning has become the norm rather than the exception, Illinois' higher education institutions are meeting the needs of the adult learner through cooperative nontraditional programming. ICCHE has served as a key organization in bringing all of higher education together in an effort to better serve the educational needs of the citizens of Illinois. ICCHE provides a forum for discussion, idea exchange, and staff networking that helps all institutions improve their educational offerings."

When asked how the current economic downturn might affect workforce development in Illinois, he took the long view. "I have been involved in workforce development for the past 30 years. Over that span of time, this is one of the most exciting times ever." Although conceding that staff development is frequently a company's first budget cut, he sees several indicators that suggest optimism.

"President-elect Obama said that he wants to rebuild America's infrastructure. That will require highly trained workers. Mr. Obama also wants to stimulate the economy, in part by providing more resources to education." Plus, he added, "America realizes that alternative forms of energy must be further developed. As the energy industry becomes more diversified, highly skilled workers at all levels will be required."

His conclusion? "Workforce development in Illinois will become more central to the strength of the State's economy than ever before."

Workforce development will also remain central to Preston Morgan's life. His work at ICCB included serving as state affiliate director for the American Council on Education's College Credit Recommendation Service (CREDIT), an organization for which he also served as a National Coordinator. "The staff at the American Council on Education was pleased to hear about my retirement from the ICCB. They have me booked through February and into March conducting course reviews and workshops." He is also talking with the American Association of Community Colleges about consulting assignments. We at ICCHE recommend that he also take some time to talk to a travel agent about booking a well-deserved vacation, but we won't take any bets on how soon that will happen. While there are still workforces to develop, we suspect that Preston Morgan will still be on the job.
